
GENERAL ORDER NO. 2006-303

ORDER


¶1 On August 4, 2006, the proposed Commonwealth Judiciary Fee Schedule was submitted to the Fifteenth Northern Mariana Islands Legislature for approval.¹ Sixty (60) days have elapsed since submission and neither house of the Legislature has disapproved of the proposed fee schedule.²


¶2 NOW, THEREFORE, IT IS HEREBY ORDERED, that the Commonwealth Judiciary Fee Schedule, attached hereto as Exhibit A and incorporated by reference herein, is effective as of the date of this Order pursuant to Article IV, §9 of the Constitution of the Commonwealth of the Northern Mariana Islands.

SO ORDERED this 4th day of October 2006.



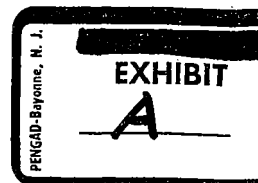
