
Dear Governor Torres:

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE THIRD SENATORIAL DISTRICT**

To re-appropriate the amount of Ninety-Two Thousand Six Hundred Fifty-Five Dollars and Eighty Cents (\$92,655.80) allotted under Saipan Local Law 20-01 and Eleven Thousand Four Hundred Fifty-Nine Dollars and Sixteen Cents (\$11,459.16) allotted under Saipan Local Law 20-23 and Five Thousand Dollars (\$5,000.00) allotted under Saipan Local Law 20-23; and for other purposes.

**BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to re-appropriate the amount of Ninety-Two Thousand Six
3 Hundred Fifty-Five Dollars and Eighty Cents (\$92,655.80) allotted under Saipan Local Law 20-
4 01 and Eleven Thousand Four Hundred Fifty-Nine Dollars and Sixteen Cents (\$11,459.16)
5 allotted under Saipan Local Law 20-23 and Five Thousand Dollars (\$5,000.00) allotted under
6 Saipan Local Law 20-23;

7 **SECTION 2. RE-APPROPRIATIONS.**

8 Notwithstanding any provisions, statutes, laws or regulations to the contrary, the Saipan
9 and Northern Islands Legislative Delegation hereby re-appropriates the following amounts:

10 (A) Ninety-Two Thousand Six Hundred Fifty-Five Dollars and Eighty Cents

1 (\$92,655.80) allotted under Saipan Local Law 20-01, specifically from Business Unit
2 4962X.

3 (B) Eleven Thousand Four Hundred Fifty-Nine Dollars and Sixteen Cents
4 (\$11,459.16) allotted under Saipan Local Law 20-23, specifically from Business Unit
5 4963G.

6 (C) Five Thousand Dollars (\$5,000.00) allotted under Saipan Local Law 20-23,
7 specifically from Business Unit 4963I.

8 The total amount set forth in Section 2(A), 2(B), and 2(C) shall be used for the asphalt
9 paving of Kahet Avenue in Kagman 3, Phase 4.

10 **SECTION 3. EXPENDITURE AUTHORITY.**

11 The expenditure authority for the funds under Section 2 of this Act shall be the Secretary
12 of the Department of Public Works.

13 **SECTION 4. FUND DISTRIBUTION.**

14 Funds appropriated under Section 2 of this Act shall be distributed accordingly to the
15 intended purpose and or entity upon this Act becoming law.

16 **SECTION 5. FISCAL YEAR.**

17 The funds allocated under this Act shall be without fiscal year limitation(s).

18 **SECTION 6. SEVERABILITY.**

19 If any provision of this Act or the application of any such provision to any person or
20 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this
21 Act or the application of its provisions to persons or circumstances other than those to which it
22 is held invalid shall not be affected thereby.

SECTION 7. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

SECTION 8. EFFECTIVE DATE.

This Act shall take effect upon its approval by the Governor or its becoming law without such approval.


