I am pleased to inform you that on Friday, August 4, 1978, I signed into law House Bill No. 1-61, entitled:

"An Act to make a technical mamendment to 5-42 as amended, relating to Deed of Trust instruments."

The amendment and Public Law No. 5-42 will provide for the use of Deed of Trust instrument for real property transactions as financed by the United States of America acting through the Farmers Home Administration or other federal agencies, including but not limited to Housing and Urban Development Agency and Veterans Administration, with the Mariana Islands Housing Authority being the trustee with the authority to foreclose by the exercise of power of sale.

To make a technical amendment to 5-42 as amended, relating to Deed of Trust instruments.

	BE IT ENACTED BY THE NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:
1	Section 1. Public Law 5-42 as amended, is hereby further amended
2	by adding a new subsection thereto, as follows:
3	"To act as Trustee on a Deed of Trust pursuant to Northern
4	Marianas Public Law 5-42, as amended, and to perform duties and functions
5	necessary or incidental to being Trustee, including, but not limited to
6	conducting public sales and making up any deficiencies after such sales."
7	Section 2. This Act shall take effect upon its approval by the
8	Governor, or upon its becoming law without such approval.
