#### AN ACT

To appropriate the sum of \$109,148.00 out of the Northern Mariana Islands Social Security Retirement Fund to defray the operation and contingent expenses of the Northern Mariana Islands Social Security Administration for fiscal year 1979.

### BE IT ENACTED BY THE FIRST NORTHERN MARIANAS COMMONWEALTH LEGISLATURE THAT:

- 1 Section 1. There is hereby appropriated out of the Northern Mariana
- 2 Islands Social Security Retirement Fund, the sum of \$109,148.00 to defray
- 3 the operation and contingent expenses of the Northern Mariana Islands
- 4 Social Security Administration from October 1, 1978 to September 30, 1979.
- 5 Section 2. The funds appropriated shall be made available to the
- 6 Administrator of the Northern Mariana Islands Social Security who shall
- 7 use these funds to carry out the purpose of this Act.
- 8 Section 3. The funds appropriated hereunder shall remain available
- 9 until September 30, 1979.
- 10 Section 4. The Northern Marianas Social Security Administrator shall
- 11 submit a report to the Legislature no later than August 31, 1979, which
- 12 shall:
- 13 (a) provide for the full disclosure of obligations incurred against
- 14 the sum appropriate by Section 1 of this Act which indicates the status of
- 15 these funds as of July 31, 1979;
- 16 (b) indicate the planned use during the final quarter of the fiscal
- 17 year, and the funds not obligated as of July 31, 1979;

1	Section 5. This Act shall take effect upon approval by the Governor
2	or upon its becoming law without such approval.
