BE IT ENACTED BY THE NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

9	c)	Rota	99,144

- 10 Section 2. Distribution of Funds. The funds appropriated by this
- 11 Act shall be made available to the respective municipal scholarship
- 12 boards in the amount allocated to the islands specified in Section 1
- 13 above; PROVIDED, however, that fifty percent of the amount allocated
- 14 to each scholarship board shall be reserved to cover financial needs
- of students for the first semester of school year 1979-1980.
- 16 Section 3. The municipal scholarship boards in the islands of
- 17 Saipan, Tinian and Rota shall submit quarterly reports to the presiding
- 18 officers of the Commonwealth Legislature on the expenditures of these
- 19 funds and the specific allocations that have been made therefrom.
- 20 Section 4. The funds made available hereunder shall remain
