"The procedures for examinations for practical nurses are the same as for registered nurses except the current series for testing will be the National Council Licensure Examinations for Practical Nurses (NCLEX-PN) for official nurse licensure. The NCLEX-PN exam will consist of Re two two-hour tests with a minimum standard score of 300 for the total examination. Examinations will be conducted once or twice a year, in April and/or October, at the descretion of the Board."
