ADOPTED REGULATIONS

The Board of Trustees of the NMI Retirement Fund hereby adopts the proposed regulations as published in the Commonwealth Register on August 1, 1988, Volume 10, No. 8, at page 5618, including the following amendments which have been duly approved and are hereby incorporated in these regulations as parts thereof, pursuant to the authority provided under 1 CMC 8314 (f), and 1 CMC 9101, et. seq.

The following changes were made and adopted:

- Section 6.6 (a). Delete subsection 6.6 (a) in its entirety and insert a new subsection 6.6 (a) in lieu thereof:
 - a. Payment of retirement benefits or other benefits issued under the Retirement Fund plan is personal to the recipient as provided in 1 CMC 8382. For this reason, the benefit shall not be assigned or paid to any person other than the recipient, unless the person lacks the legal capacity to directly receive the benefit, as follows:
 - 1) the recipient is under the age of 18 years;
 - the recipient has been declared, by a court of competent jurisdiction to be mentally incapable of managing his/her own affairs, financial or otherwise;
 - 3) the recipient has been declared, in writing, by two licensed and practicing physicians, selected by the Board of Trustees, to be mentally incapable of managing his/her own affairs, financial or otherwise, and the Board of Trustees has confirmed the physician's decision after notice and an opportunity for hearing to the mentally incapable individual.

- 2. <u>Subsection 6.6 (c)</u>. On the first sentence, change the reference from "Section 6.6 (a)(ii)" to "Section 6.6 (a)(2) and (3)".
- 3. <u>Subsection 6.6 (d)</u>. On the first sentence, change the reference from "Section 6.6 (a)(ii)" to "Section 6.6 (a)(2) and (3)".
- 4. <u>Subsection 6.7 (a).</u> On the first sentence, change the reference from "Section 6.6 (a)(ii)" to Section 6.6 (a)(2) and (3)".
- 5. <u>Subsection 6.8 (b).</u> On the first sentence, insert the phrase "and the Board so directs,", after "...pursuant to Section 6.8(a),".
- 6. <u>Subsection 6.8 (c)</u>. Delete the phrase "shall appoint or designate another qualified person to be the payee as described in Section 6.6 (c)." and insert the following phrase in lieu thereof "may require that another qualified person be appointed or designated to be the payee as described in Section 6.6(c)."

PROPOSED AMENDMENTS TO REGULATIONS FOR MEDICAL PROFESSION LICENSING

The Medical Profession Licensing Board, pursuant to 3 CMC section 2214(a), proposes the following amendments to the Regulations for Licensing of Health Care Professionals published in 8 Commonwealth Register, No. 7, October 22, 1986. These amendments shall become effective at 12:01 AM, January 1, 1989.

Regulation 1-15 is amended to read in its entirety as follows:

<u>1-15.</u> Licenses: Fees. The licensing fee for each professional area shall be not less than twenty-five dollars (\$25.00) and not more than one hundred dollars (\$100.00) for a twenty-four (24) month license, as the Board shall determine. The same fee shall apply to initial issuance and to renewal.

Regulation 1-16 is amended to read in its entirety as follows:

<u>1-16. Period of Validity--Renewal of License.</u>

1. Licenses shall be valid for a period of twenty-four (24) calendar months from date of issue, and shall expire on the last day of the twenty-fourth calendar month after issue or renewal. Licenses must be renewed on or before the last day of the twenty-fourth calendar month after issue, except that if the last day of the period of validity falls on a Saturday, Sunday or legal holiday, the license must be renewed by the close of business of the next following business day.

2. The renewal fee must be paid to the Board in full at the time of application for renewal.

3. In the event of failure to renew before expiration, a license may be reinstated and the license renewed upon payment of the renewal fee plus a penalty of twenty-five dollars (\$25.00) for each month of delinguency, accruing in full on the first day of the month. Renewal shall run from the original date of expiration.

4. Transition to 24 month renewal.

(a) All licenses issued on or after December 31, 1987, and prior to January 1, 1989, shall remain effective through December 31, 1988.

(b) All licenses issued on and after January 1, 1989 shall expire as provided in 1-16.1 above.
