NOTICE OF AMENDMENT UNDERGROUND INJECTION CONTROL REGULATIONS FOR PUBLIC LAW 3-23 DEPARTMENT OF PUBLIC HEALTH & ENVIRONMENTAL SERVICES

The Director of the Department of Public Health and Environmental Services of the Commonwealth of the Northern Mariana Islands hereby amends the regulations establishing requirements for any underground injection of hazardous wastes of fluids used for extraction of minerals, oil, and energy, and of certain other fluids with potential to contaminate groundwater in order to protect underground sources of drinking water which were published in the Commonwealth Register Volume 6, Number 5, May 15, 1984, Page 2802-2813. These amended regulations are promulgated pursuant to the authority granted the Director of Public Health and Environmental Services under Public Law 3-23. The regulations prohibit deep injection of wastes, injection of hazardous wastes, injection of fluids associated with oil and gas mining, solution mining, and other categories identified in the proposed regulations. They allow all other types of injection to exist, subject to applicable regulations. They do not apply to drinking water supply wells, water production wells, monitoring well drilling, development, and rehabilitation processes.

Copies of the regulations may be obtained from the Department of Public Health and Environmental Services, Division of Environmental Quality, located at Dr. Torres Hospital, Saipan, CM 96950. These regulations become effective within ten (10) days from the date this notice is published in the Commonwealth Register.

AMENDMENTS TO UNDERGROUND INJECTION CONTROL REGULATIONS

Part III(s) of the Underground Injection Control Regulations is hereby amended to read as follows:

(s) "Pollutant" means any fluid that contains a contaminant, or dredged spoil, solid waste, incinerator residue, filter backwash, sewage, garbage, sewage sludge, munitions, chemical wastes, biological materials, radioactive materials, heat, wrecked or discarded equipment, rock, sand, cellar dirt and industrial, municipal, and agricultural waste discharged in water. It does not mean sewage from vessels.

Part 5.3 of the Underground Injection Control Regulations is hereby amended to read as follows:

5.3 Owners and operators of Class V Wells are prohibited from causing or allowing movement of fluid, by injection or otherwise, containing any contaminant into underground sources of drinking water where the presence of that contaminant may cause a violation of the CNMI Drinking Water Regulation, or which in the opinion of the Department may adversely affect the health of persons.

Part 6.1 of the Underground Injection Control Regulation is hereby amended as follows:

6.1 These regulations do not prohibit the construction, installation, operation or maintenance of any type of injection well not included in Classes I-IV, provided that there is compliance with these regulations and other applicable regulations and statutes. Any project, or proposed project, that may cause underground injection of hazardous wastes, of

fluids used for extraction of minerals, oil, and energy and of certain other fluids with potential to contaminate ground water, in addition to being subject to these regulations, is subject to the Coastal Resources Management regulations governing projects which are designated as a "Major Siting," or which are located or proposes to be located in an "Area of Particular Concern," as defined in the Coastal Resources Management regulations.

PROPOSED AMENDMENT TO TERMINAL TARIFF

§ 1. Paragraph D of Part VI of the Terminal Tariff
is hereby Amended to read as follows:

"D. Home Port Fee. Rates and fees for vessels operating in the Territorial waters of the Commonwealth on a continuing and long-term basis may be established by agreement, exclusive of this Terminal Tariff, pursuant to the powers conferred upon CPA by law. In the absence of such an agreement, all of the rates and fees set forth in this Terminal Tariff and elsewhere in the Harbor Regulations shall apply, except that the dockage rates shall be as follows:

Overall length of Vessel in Feet:		Charge per month
Over	But Not Over	or fraction thereof
0	25	\$15.00
25	75	\$25.00
75	100	\$75.00
100	150	\$100.00
150	---	Daily rates specified in Part V.D shall apply.

§ 2. This Amendment shall take effect upon its adoption by the Authority, and upon its promulgation in the manner provided by law.



BID PROTEST AND APPEALS PROCEDURES

1. Scope:

These Procedures apply to protests by interested parties of procurement actions undertaken by agencies of the Commonwealth of the Northern Mariana Islands in which the procurement actions are funded or are expected to be funded in whole or in part with funds of the United States Government granted to the Commonwealth and subject to the requirements of Office of Management and Budget Circular A-102.

2. Computation of Time:

- a. Except as otherwise specified, all "days" referred to in these Procedures are deemed to be working days of the Commonwealth Government. The term "file" or "submit" except as otherwise provided refers to the date of transmission;
- b. In computing any period of time prescribed or allowed by these Procedures, the day of the act or event from which the designated period of time begins to run shall not be included.

3. Protests to the Contracting Officer:

a. General:

- (1) Any actual or prospective bidder, offeror, or contractor who is aggrieved in connection with the solicitation or award of a contract may protest to the contracting officer. The protest shall be received by the contracting officer in writing within ten (10) days after such aggrieved person knows or should have known of the facts giving rise thereto. Contracting officers shall consider all protests or objections to the award of a contract, whether submitted before or after award. If a protest is oral and the matter cannot be resolved, written confirmation of the protest shall be requested by the contracting officer. The written protest shall state fully the factual and legal grounds for the protest;
- (2) Other persons, including bidders, involved in or affected by the protest shall be given notice of the protest and its basis in appropriate cases. These persons shall also be advised that they may submit their views and relevant information to the contracting officer within a specified period of time. Normally, the time specified will be one (1) week;

(3) The contracting officer shall decide the protest within thirty (30) calendar days after all interested parties have submitted their views unless he certifies that the complexity of the matter requires a longer time, in which event he shall specify the appropriate longer time.

(4) When a protest, before or after award, has been appealed to the Public Auditor as provided in these Procedures, and the contracting officer is requested to submit a report, the contracting officer should include with his report a copy of:

- (i) the protest;
- (ii) the bid submitted by the protesting bidder and a copy of the bid of the bidder who is being considered for award, or whose bid is being protested;
- (iii) the solicitation, including the specifications on portions relevant to the protest;
- (iv) the abstract of offers or relevant portions;
- (v) any other documents that are relevant to the protest; and
- (vi) the contracting officer's signed statement setting forth findings, actions, and recommendations and any additional evidence or information deemed necessary in determining the validity of the protest. The statement shall be fully responsive to the allegation of the protest. If the award was made after receipt of the protest, the contracting officer's report will include the determination prescribed in subparagraph (b)(4) below.

(5) Since timely action on protests is essential, they should be handled on a priority basis. Upon receipt of notice that an appeal from the contracting officer's decision has been taken to the Public Auditor, the contracting officer shall immediately begin compiling the information necessary for a report as provided in subsection (4) above. To further expedite processing, the official who furnishes the agency's report should, upon request of the protester or the Public Auditor, simultaneously furnish a complete copy (except for information privileged by law or which the contracting officer deems must be confidential in order to benefit from competitive bidding) to the protester. In such instances, the protester shall be requested to furnish a

copy of any comments on the administrative report directly to the Public Auditor as well as the contracting officer.

b. Protests Before Award:

(1) The contracting officer shall require that written confirmation of an oral protest be submitted by the time specified in section 3(a)(1) and may inform the protester that the award will be withheld until the specified time. If the written protest is not received by the time specified, the oral protest may be disregarded. An award may be made in the normal manner unless the contracting officer finds it necessary in his discretion to take remedial action.

(2) When a proper protest against the making of an award is received, the award will be withheld pending disposition of the protest. The bidders whose bids might become eligible for award should be informed of the protest. In addition, those bidders should be requested, before expiration of the time for acceptance of their bids, to extend the time for acceptance to avoid the need for readvertisement. In the event of failure to obtain such extensions of bids, consideration should be given to proceeding with an award under subparagraph (3) below.

(3) When a written protest is received, award shall not be made until the matter is resolved, unless the contracting officer determines that:

- (i) the materials and services to be contracted for are urgently required;
- (ii) delivery or performance will be unduly delayed by failure to make award promptly; or
- (iii) a prompt award will otherwise be advantageous to the Commonwealth.

(4) If award is made under subparagraph (3) above, the contracting officer shall document the file to explain the need for an immediate award. The contracting officer also shall give written notice to the protester and others concerned of the decision to proceed with the award.

c. Protests After Award:

Although persons involved in or affected by the filing of a protest after award may be limited, in addition to the

contracting officer, at least the contractor shall be furnished the notice of protest and its basis in accordance with subparagraph (a)(2) above. When it appears likely that an award may be invalidated and a delay in receiving the supplies or services is not prejudicial to the Government's interest, the contracting officer should consider seeking a mutual agreement with the contractor to suspend performance on a no-cost basis.

4. Appeals of Contracting Officer Decisions to the Public Auditor:

a. Jurisdiction; Exhaustion of Remedies. A written appeal to the Public Auditor from a decision by the contracting officer may be taken provided that the party taking the appeal has first submitted a written protest to the contracting officer as provided in section 3 of these Procedures, and the contracting officer has denied the protest or has failed to act on the protest within the time provided for in section 3(a)(3) above.

b. Form of Appeal. No particular form of pleading is required for filing an appeal to the Public Auditor. The appeal shall, however:

- (1) Include the name and address of the appellant;
- (2) Identify the contracting agency and the number of the solicitation or contract;
- (3) Contain a concise, logically arranged, and direct statement of the grounds for appeal; and
- (4) Specifically request a ruling by the Public Auditor.

c. Time for Filing Appeal. An appeal from the contracting officer's decision must be received by the office of the Public Auditor not later than ten (10) days after the appellant receives the decision of the contracting officer, or, in the event that the contracting officer has not decided the protest within ten (10) days from the date that he should have decided the protest pursuant to section 3(a)(3) above. Any appeal received after these time limits shall not be considered by the Public Auditor unless good cause is shown or unless the Public Auditor determines that the appeal presents issues significant to procurement practices that are not outweighed by the detriment to the Commonwealth should the appeal be considered.

d. Notice of Protest, Submission of Contracting Officer Report and Time for Filing of Comments on Report.

(1) The Public Auditor shall notify the contracting agency by telephone and in writing within one (1) day of the receipt of an appeal, requesting the agency to give notice of the appeal to the contractor if award has been made or, if no award has been made, to all bidders or proposers who appear to have a substantial and reasonable prospect of receiving an award if the appeal is denied. The contracting officer shall be requested to furnish in accordance with section 3(a)(2) of these Procedures copies of the protest and appeal documents to such parties with instructions to communicate further directly with the Public Auditor.

(2) Material submitted by an appellant will not be withheld from any Commonwealth or federal agency which may be involved in the appeal except to the extent that the withholding of information is permitted or required by law or regulation. If the appellant considers that the protest contains material which should be withheld, a statement advising of this fact must be affixed to the front page of the appeal document and the allegedly proprietary information must be so identified wherever it appears.

(3) The Public Auditor shall request the contracting officer to submit a complete report on the appeal to the Public Auditor as expeditiously as possible (generally within 25 working days) in accordance with section 3(a)(4) of these Procedures and to furnish a copy of the report to the appellant and other interested parties as defined in section 4(d)(3).

(4) Comments on the agency report shall be filed with the Public Auditor within ten (10) days after the Public Auditor's receipt of the report, with a copy to the agency office which furnished the report and to other interested parties. Any rebuttal an appellant or interested parties may care to make shall be filed with the Public Auditor within five (5) days after receipt of the comments to which rebuttal is directed, with a copy to the agency office which furnished the report, the appellant, and interested parties, as the case may be. Unsolicited agency rebuttals shall be considered if filed within five (5) days after receipt by the agency of the comments to which rebuttal is directed.

(5) The failure of an appellant or any interested party to comply with the time limits stated in this section may result in resolution of the appeal without consideration of the comments untimely filed.

e. Withholding of Award. When an appeal has been filed before award, the agency will not make an award prior to resolution of the protest except as provided in section 3(b)(4) of these Procedures. In the event the agency determines that award is to be made during the pendency of an appeal, the agency will notify the Public Auditor.

f. Furnishing of Information on Protests. The Public Auditor shall, upon request, make available to any interested party information bearing on the substance of the appeal which has been submitted by interested parties or agencies, except to the extent that withholding of information is permitted or required by law or regulation. Any comments thereon shall be submitted within a maximum of ten (10) days.

g. Time for Submission of Additional Information. Any additional information requested by the Public Auditor from the appellant or interested parties shall be submitted no later than five (5) days after the receipt of such request. If it is necessary to obtain additional information from the agency, the Public Auditor will request that such information be furnished as expeditiously as possible.

h. Conference.

(1) A conference on the merits of the appeal with the Public Auditor may be held at the request of the appellant, any other interested party, or an agency official. Request for a conference should be made prior to the expiration of the time period allowed for filing comments on the agency report. Except in unusual circumstances, requests for a conference received after such time will not be honored. The Public Auditor will determine whether a conference is necessary for resolution of the appeal.

(2) Conferences normally will be held prior to expiration of the period allowed for filing comments on the agency report. All interested parties shall be invited to attend the conference. Ordinarily, only one conference will be held on an appeal.

(3) Any written comments to be submitted and as deemed appropriate by the Public Auditor as a result of the conference must be received in the Office of the Public Auditor within five (5) days of the date on which the conference was held.

(i) Time for Decision; Notice of Decision:
The Public Auditor shall, if possible, issue a decision on the appeal within 25 days after all information necessary for the resolution of the appeal has

been received. A copy of the decision shall immediately be mailed or otherwise transmitted to the appellant, other participating parties, and the contracting officer.

j. Request for Reconsideration:

(1) Reconsideration of a decision of the Public Auditor may be requested by the appellant, any interested party who submitted comments during consideration of the protest, and any agency involved in the protest. The request for reconsideration shall contain a detailed statement of the factual and legal grounds upon which reversal or modification is deemed warranted, specifying any errors of law made or information not previously considered.

(2) Request for reconsideration of a decision of the Public Auditor shall be filed not later than ten (10) days after the basis for reconsideration is known or should have been known, whichever is earlier. The term "filed" as used in this section means receipt in the Office of the Public Auditor.

(3) A request for reconsideration shall be subject to these bid protest procedures consistent with the need for prompt resolution of the matter.

5. Remedies:

a. Remedies Prior to Award. If prior to award the contracting officer or the Public Auditor determines that a solicitation or proposed award of a contract is in violation of law or regulation, then the solicitation or proposed award shall be:

(1) cancelled; or

(2) revised to comply with law or regulation.

b. Remedies After an Award. If after an award the contracting officer or the Public Auditor determines that a solicitation or award of a contract is in violation of law or regulation, then:

(1) if the person awarded the contract has not acted fraudulently or in bad faith:

(i) the contract may be ratified and affirmed, provided it is determined that doing so is in the best interests of the Commonwealth; or

(ii) the contract may be terminated and the person awarded the contract shall be compensated for the actual expenses reasonably incurred under the contract, plus a reasonable profit, prior to termination;

(2) if the person awarded the contract has acted fraudulently or in bad faith:

(i) the contract may be declared null and void; or

(ii) the contract may be ratified and affirmed if such action is in the best interests of the Commonwealth, without prejudice to the Commonwealth's rights to such damages as may be appropriate.

c. Finality of Findings of Fact by the Public Auditor. A determination of an issue of fact by the Public Auditor under these Procedures shall be final and conclusive unless arbitrary, capricious, fraudulent, or clearly erroneous.


PUBLIC NOTICE

On January 1, 1984 the Office of the Attorney General began the ambitious task of reviewing and updating the files of all Commonwealth corporations, nonprofit corporations, and registered foreign corporations. There are presently over 1,000 such corporations.

All corporations organized for profit under Commonwealth law and all nonprofit corporations must annually file an exhibit of their affairs as of December 31 on a form provided by the Registrar by April 1st of the following year. Section 5.4 and 5.5 of the Regulations on Corporations, Territorial Register, Vol. 1 No. 1 - July 15, 1974. If a corporation has failed or neglected, for a period of two years in succession, to file an annual exhibit the Registrar may disincorporate the corporation after providing notice of such intention by mailing notice to the corporation and by publishing notice of such intention. Section 6.2 of the Regulations on Corporations.

Over 400 corporations have failed to file an annual exhibit for a period of two years in succession. A notice to this effect was mailed to each one. Several immediately filed updated exhibits. The remainder either replied requesting that they be dissolved or failed to reply at all. Those corporations will be dissolved by this notice if an annual exhibit is not filed prior to November 10, 1984. The following is a list of those corporations. On November 15, 1984 a list of dissolved corporations will be published in the Commonwealth Register.
