**PUBLIC NOTICE OF PROPOSED
REPLACEMENT OF ENTIRE CHCC CHARGEMASTER AND
NEW BUREAU OF ENVIRONMENTAL HEALTH FEES
AND
REPEAL AND REPLACEMENT OF
ENTIRE NMIAC SUBCHAPTER 140-10.8,
SCHEDULE OF MEDICAL AND OTHER RELATED FEES**

INTENDED ACTION TO ADOPT THESE PROPOSED REVISIONS TO THE RULES AND REGULATIONS: The Commonwealth Healthcare Corporation (CHCC) intends to adopt as permanent the attached new Chargemaster and Bureau of Environmental Health (BEH) Fees, pursuant to the procedures of the Administrative Procedure Act, 1 CMC § 9104(a). The replacement of the entire Chargemaster and the new BEH Fees will become effective 10 days after adoption and publication in the Commonwealth Register. (1 CMC § 9105(b))

AUTHORITY: The Board of Trustees may prepare and adopt rules and regulations to assure delivery of quality health care and medical services and the financial viability of the Corporation that will best promote and serve its purposes. 3 CMC Section 2826(c).

THE TERMS AND SUBSTANCE: The new CHCC Chargemaster has been completely revised and updated, as has the BEH Fees. The current NMIAC Subchapter 140-10.8, Schedule of Medical and Other Related Fees will be repealed and replaced in its entirety. Part 100 will be the new Chargemaster. Part 200 will be the new Bureau of Environmental Health Fees.







This proposed repeal and replacement was approved by the CHCC Board of Trustees and the CHCC CEO.


